<b>S-A</b>	<b>BUDGET MESSAGE</b>	W.S. 16-4-104(d)
<p>Revenue as well as regular administrative expenses remain constant. The Operation Budget will include an addition \$1,000 for snow fencing. We were fortunate that there was not a lot of snow removal required during the current fiscal year ending 6/30/2019. However, we are maintaining this budget item at a high level for fiscal year ending 6/30/2020 because snow removal is the most erratic and unpredictable item in the budget. <b>** We have ammended the budget due to a heavier snowfall and blowing snow to keep roads clear for the subdivision. Will reduce the amount we put into reserve for this fiscal year by \$3500.</b></p>		

<b>S-B</b>	<b>RESERVE DESCRIPTION</b>
<p>We will continue to put all extra monies left over from revenues collected, minus regular Webb Creek administrative and operation expenses in the reserve fund at the beginning of the next fiscal year once numbers are final. The Reserve Fund is used primarily to maintain our roads, but may be used for other emergencies as needed. For YE: 6/30/2020 we plan to spend \$20,000 to do minor repairs to the roads.</p>
