S-A BUDGET MESSAGE W.S. 16-12-403 (c)

Funds for the Cattle Trail Acres ISD are used primarily for road maintenance of Cattle Trail Drive. The Natrona County Treasurer collects \$800 per year in special assessments from each of the 7 homeowners (for a total of \$5,600 per year). We budgeted \$5,600 for 2021-22, and spent \$1,800 for snow removal and blading. We also needed to open up a checking account specifically for the ISD, and \$25 was spent on check blanks. The current balance of the checking account is \$9,375.33, which includes interest earned from Natrona County Treasurer, as well as money collected from the homeowners property taxes last fall and this spring. All homeowners are current in their taxes.
