Pursuant to the Wyoming Administrative Procedures Act, W.S.16-3-103 et seq., W.S. 18-3-504, and W.S. 18-5-201 through W.S. 18-5-314, the Board of County Commissioners of Natrona County (BOCC) will hold a public hearing on the 19th day of March, 2024 to consider resolutions repealing resolutions 36-18, 37-18, 38-18; 39-18; 40-18; 41-18; 57-18; 44-20; 46-20; 84-03 and any other resolutions or portions of resolutions in conflict with updated codes. The BOCC will also consider resolutions adopting the 2021 editions of the International Building, Residential, Fire, Existing Building, Plumbing, Fuel Gas, and Mechanical Codes, as modified; the 2023 editions of the National Electric and National Electrical Safety Codes, as modified; and a resolution for the Establishment of and Rules of Practice for the Natrona County Development Board of Appeals. A copy of the proposed new resolutions with modifications to the international codes are available on the Natrona County website- www.natronacountywy.gov, and in the office of the Natrona County Building Department, Room 205, 200 N. Center Street, Casper, WY 82601.

The proposed resolutions will update the current rules of Natrona County from the 2018 to the 2021 editions of the listed codes and from the 2020 to the 2023 Electrical codes. Further, the modifications to the codes will help clarify and cleanup language of the codes and previous resolutions. The resolution for the establishment of the rules and practice of the Development Board of Appeals will update and clarify language from the previous resolution establishing the board of appeals.

On Tuesday March 19, 2024, at 5:30 pm, in the Natrona County Courthouse, District Courtroom #1, the BOCC will open the public hearing to hear public comment and consider the proposed resolutions and rules. Additionally, prior to the public hearing, any interested person may submit his/her written views on the proposed rules to the office of the Board of County Commissioners, room 211, 200 N. Center St., Casper, WY 82601, or to pvirrill@natronacounty-wy.gov. The originally published date has been changed to the regularly scheduled BOCC meeting on March 19, 2024.

The proposed codes do not exceed the minimum substantive state statutory requirements and are not necessary to comply with a federal law or regulatory requirement.
